wetlands. In addition, an irrigation ditch exists immediately up gradient from these areas and direct observations identifies that it actively leaks water into or within the vicinity of the wet areas. In accordance with the Corps and EPA wetland definition from the 1987 “Corps of Engineers Wetland Delineation Manual”, wetlands are “Those areas that are inundated or saturated by surface or ground water at a frequency and duration sufficient to support, and under normal circumstances do support, a prevalence of vegetation typically adapted for life in saturated soil conditions. Wetlands generally include swamps, marshes, bogs, and similar areas.” Therefore, an irrigated area, under normal circumstances, does not meet the definition of a wetland. The South Pacific Division Regulatory Program Wetlands Determination and Delineation Procedures for Irrigated Fields further identifies that, “If it is obvious that the area would not meet the wetland hydrology factor without irrigation based on the information obtained and/or field observations, the area does not meet the Corps/EPA definition of a wetland under the procedures in the 1987 manual and regional supplement.”

PWUS-2 (0.015 acre) does not contain evidence of an ordinary high water mark and as such is not a waters of the U.S.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: In 1991, Simmons Land and Cattle Company applied and was granted a water right to build a storage pond at the point where water enters the property. This storage pond is referred to as Wet-A. Conversations with the current landowner (Butch Keller) said that Simmons Land and Cattle Company historically pumped water from this pond to the southern extent of the property. Mr. Keller explained that he ceased pumping after irrigation return flows that filled this pond reduced in quantity. Although water is actively leaking onto the neighboring property, active irrigation on this property had ceased and therefore irrigation return flows that hydrate Wet-A have diminished. As a result, Wet-A appears much drier with thistle encroaching where cattails historically had grown.
