Explain: **The Addendum Review Area covers approximately 163.5 acres in three distinct areas, referred to herein as 1) IPP Road Crossing (Latitude 39.1996°, Longitude -112.8976°), 2) Access Road G2 (Latitude 39.1341°, Longitude -113.0507°), and 3) Drop Structure (Latitude 39.0952°, Longitude -112.9985°). All of these areas are**

within the drainage of the Sevier Lake/Playa. The Sevier Playa was evaluated during 2013 and during 2017 under this same project file number (SPK-2013-00295) and both times the Corps determined that the Sevier Playa was an intrastate isolated feature with no apparent interstate or foreign commerce connection. The Sevier [Dry] Lake is a remnant of ancient glacial Lake Bonneville and is located in a closed basin at the terminus of the Sevier River and does not drain/connect to a TNW. Water from the Sevier River is almost entirely diverted for irrigation purposed throughout the upstream length of the river prior to its confluence with the Sevier [Dry] Lake. Therefore, Sevier Lake has been virtually dry throughout recorded history except for brief periods of unusually high precipitation and runoff in 1913, 1922, mid 1980s, and 2011. The area is not navigable and cannot be tied to interstate or foreign commerce due to absence of water. Sevier [Dry] Lake does not consistently or regularly receive water such that physical indicators of an OHWM could develop. The nearest TNWs, Mona Reservoir, Sevier Bridge Reservoir (Yuba Lake), and Paiute Reservoir are approximately 80 miles northeast, 56 miles east, and 68 miles southeast of the study area, respectively. Mona Reservoir is located in a different watershed and both Paiute and Sevier Bridge (Yuba Lake) Reservoirs are located upstream of Sevier Lake. Sevier Lake is an intrastate, isolated feature with no interstate or foreign commerce connection.

The three Addendum Review Areas were evaluated for the presence of aquatic resources during 2018, and the evaluation revealed the presence of one wetland area (W01), totaling 0.66 acre and one intermittent drainage (W03 – Sevier River) that exhibited an OHWM, totaling 0.11 acre. While the one wetland feature meets the wetland delineation criteria in the 1987 Wetland Delineation Manual, this feature is located in the Sevier [Dry] Lake watershed, described above and has no connection with a TNW. Similarly, while the intermittent drainage (Sevier River) occasionally contributes water to the closed basin Sevier [Dry] Lake, the dry lake has been determined to be uplands, and therefore the Sevier River does not connect to a TNW. Based on the above, the wetland (0.66 acre) and the intermittent drainage (Sevier River) (0.11 acre) in the Addendum Review Area are both intrastate, isolated features. No interstate or foreign commerce connections could be attributed to any of these aquatic resources.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
