Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The 0.36-acre pond and 0.24-acre wetland within the study area are located in a topographically low point surrounded by roads and industrial development. The pond receives storm water runoff from the adjacent parking lots and groundwater input which, when levels are high enough, provides hydrology to the adjacent wetland during much of the growing season. It is unclear if the aquatic features on site were part of a larger drainage system before development or if they were excavated in uplands for storm water collection. Currently, these features do not have a surface connection to other drainages or aquatic features. The eastern wetland boundary is approximately 30 feet from a recently installed box grate, which is connected to the storm drain system that discharges in Dry Creek, approximately 4,500 feet to the north of the project area. There is a 3-

foot rise from the wetland to the grate and there is no potential for water in the study area to reach the storm drain system, except during extremely high water events. There is no evidence to suggest that water has ever reached this level. The box grate can be closed off and disconnected from the storm drain system with control gates. The Corps has determined that the pond and wetland identified within the study area are isolated features with no apparent interstate or foreign commerce connection. As such, these features are not currently subject to CWA Section 404 regulation.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
