Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: There are nine isolated non jurisdictional stream channels within the review area. They include two intermittent streams, Crowley Creek A and Channel 17, and seven ephemeral streams, Channels 4B, 4C, 11, 22, Crowley Creek D, Crowley Creek E and Pole Creek. There are also 10 isolated non jurisdictional wetlands (Wetlands 20-22, 22/23 PEM1C, 22/23 R4SB7, WM 23 PEM1C, WM 23 R4SB7, 2011 Wetland 1, 2011 Wetland 2 and 2011 Wetland 5) totaling 4.735 acres. Features 4, 4A, 5, 6, 7, 8, 9, 10, 12, 13, 14, 15, 16, 18, 19, 20, 23, 24, 25, 26 and 27, all lack any indication of OHWM and are not jurisdictional.

Features 4, 4A, 5, 6, 7, 8, 9, 10, 19, 20, 23, 24, and Channel 22 flow to Channel 4B. Features 12, 13, 14, 15, 16, 25, 26 and Channel 11 and 4B flow to Channel 4C. Channels 4C, 17 and Pole Creek Crowley Creek A. Crowley Creek A drains to Crowley Creek D, Crowley Creek D drains to Crowley Creek E. Crowley Creek E dissipates into uplands and loses all OHWM indicators 1.1-mile from the Quinn River. There is no indication of any connection of flows from Crowley Creek to the Quinn River, the closest potential jurisdictional water. Channels 22, 4B, 4C, 11, 17, Pole Creek and Crowley Creek have no known connection to interstate commerce.

There are 10 wetlands present within the review area. Wetlands 21, 22/23 PEM1C and 22/23 R4SB7 abut Pole Creek. Wetland 20 abuts Channel 4C. Wetlands WM 23 PEM1C and WM 23 R4SB7 directly abut Crowley Creek. Wetland 2011 Wetland 5 is adjacent to Channel 4C. Wetland 20 is adjacent to Pole Creek. Wetlands 2011 Wetland 1 and 2011 Wetland 2 are adjacent to Channel 11. Since Crowley Creek is an isolated channel with no connection to waters of the US or interstate commerce, wetlands that flow to it are also isolated features and non-jurisdictional.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. **C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Channel 30. Channel 30 flows to Channel 3B. Channel 3B flows westward connecting to Thacker Creek. Thacker Creek then flows into an irrigation impoundment used to irrigate a nearby field. There is no indication of any connection of flows from Thacker Creek to Kings River, the closest potential jurisdictional water approximately 2 miles from the irrigation impoundment. Feature 3B and Thacker Creek have no known connection to interstate commerce.

There are 23 wetlands present within the review area. Wetlands 1, 2 and 13 abut Channel 30. Wetland 3 abuts Channel 3B. Wetlands 4 PEM1C, 4PEM1F, 5,12, 15, 17, 19 PEM1C, 19 PSS1C, Thacker reservoir and Thacker Riparian directly abut Thacker creek.
