This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

At the point of confluence between the North Truckee Drain and the Truckee River, the Truckee River meets the definition of navigable in fact, having both current and historic navigation and historic interstate commerce. The subject channels each have a more than speculative effect on the physical and chemical integrity of the Truckee River.

The findings of Maurer et al. (2008) demonstrated that unit-area runoff from perennial watersheds is greater than unit-area runoff from ephemeral watersheds within Northern Nevada watersheds. They found that ephemeral tributaries, like the subject channels, reduce stormwater and non-point source pollutant input to downstream TNWs. AR-3 accomplishes this by allowing infiltration that also provides basin aquifer recharge. The subject channels each provide water, reduce stormwater and non-point source pollutant in the downstream TNW. This process, which occurs in each of these tributaries, captures pollutants in the headwaters and reduces pollutant input to the downstream TNW.
