- B. ADDITIONAL COMMENTS TO SUPPORT JD: The wetland in question is part of a larger wetland complex. On December 13, 2006 (SPK-200675471), the Corps determined that portions of this wetland complex were intrastate, isolated wetlands and therefore not waters of the U.S. The wetland extends to the southwest towards Mineral Creek but transitions to upland conditions prior to US Highway 550. There are no culverts conveying flows from the wetland complex under an existing residential development and highway to Mineral Creek. According to aerial images, water could flow southeast from this wetland complex into a ditch. The ditch conveys water into a depressed scrub shrub wetland. This scrub shrub wetland does not have an outlet and does not extend to nor is in the floodplain of the Animas River. On November 8, 2018 (SPK-201800794), the Corps determined that a wetland that also flows into the same scrub shrub wetland was an intrastate, isolated wetland and therefore not a waters of the U.S. The Corps' Headquarters and EPA concurred with this determination on November 16, 2020, and November 23, 2020, respectively.
