Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: No potential wetlands and a total of 29 potential drainages were identified and inventoried during a field survey. Of those potential waters surveyed, Drainages 1, 35, and 36 are the only drainages within the survey area that exhibit an Ordinary High Water Mark (OHWM).

Drainage 1 enters the survey area near the western boundary of the proposed mining area and flows south.

Drainage 1 is an ephemeral channel that exhibits an OHWM for 531 linear feet within the delineated area.

Drainages 35 and 36 cross an existing gravel road in the northern portion of the survey area and flow north.

Drainage 35 is an ephemeral channel that exhibits an OHWM for 100 linear feet within the delineated area.

Drainage 36 is an ephemeral channel that exhibits an OHWM for 152 linear feet within the delineated area.

Drainages 1, 35, and 36 lose all OHWM indicators outside of the survey area before connecting to a jurisdictional drainage. Drainage 1 loses OHWM approximately 2,800 feet down-gradient from the location where the drainage exits the survey area and prior to connection with another drainage. Drainage 35 loses OHWM approximately 2,000 feet down-gradient from the location where the drainage exits the survey area and prior to connection with another drainage. Drainage 36 loses OHWM approximately 1,000 feet down-gradient from the location where the drainage exits the survey area and prior to connection with another drainage. Therefore, Drainages 1, 35, and 36 in the survey area are considered intrastate isolated aquatic resources with no connection to a traditional navigable water.

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

##### **B. ADDITIONAL COMMENTS TO SUPPORT JD:**

The mine site resides within the northern portion of the Dixie Valley Watershed (HUC Number 16060001), which is a part of the Central Region Watershed in central Nevada. The survey area resides in an isolated sub-basin within the Dixie Valley Watershed. All surface water that is conveyed through the survey area terminates in the valley floor of Bell Flats located approximately 3 miles south of the project. Drainage 1 enters the survey area near the western boundary of the proposed mining area and flows south. Drainage 1 is an ephemeral channel that exhibits an OHWM for 531 linear feet within the delineated area. Drainages 35 and 36 cross an existing gravel road in the northern portion of the survey area and flow north. Drainage 35 is an ephemeral channel that exhibits an OHWM for 100 linear feet within the delineated area. Drainage 36 is an ephemeral channel that exhibits an OHWM for 152 linear feet within the delineated area.

Drainages 1, 35, and 36 lose all OHWM indicators outside of the survey area before connecting to a jurisdictional drainage. Drainage 1 loses OHWM approximately 2,800 feet down-gradient from the location where the drainage exits the survey area and prior to connection with another drainage. Drainage 35 loses OHWM approximately 2,000 feet down-gradient from the location where the drainage exits the survey area and prior to connection with another drainage. Drainage 36 loses OHWM approximately 1,000 feet down-gradient from the location where the drainage exits the survey area and prior to connection with another drainage. Drainages 1, 35, and 36 are not interstate waterways and there is no interstate commerce associated with their use. Therefore, Drainages 1, 35, and 36 in the survey area are considered intrastate isolated aquatic resources with no connection to a traditional navigable water.
