Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The study area is approximately 76 acres of a proposed housing development. Middle Canyon Creek an ephemeral drainage bisects the project site from south to north. This channel exhibits an ordinary high water mark for approximately 3,996 linear feet (0.57 acre) of the project area and has been determined to be an intrastate isolated water.

This channel only flows after flood events and is eroded and incised and lacks a low floodplain. The channel has been straightened by farmers, which has resulted in head cuts, gravel plugs, and narrow to wide sections. There are four gaps where the OHWM is absent and flows seem to be conveyed either overland or subsurface.

The channel flows offsite on the western portion of the site through a culvert underneath 2000 North Street. The channel continues west underneath the railroad and northwest under SR-36. At this point the channel flows into a field and splits 0.3 miles northwest of SR-36 culvert. The eastern channel flows generally north and dissipates south of West Cimmarron Way, approximately 1.5 miles north from the split. The western channel flows generally northwest and dissipates adjacent to 1200 West and north of the wastewater treatment plant, approximately 2 miles northwest of the channel split. No potential downstream channel connections could be identified further north of these channels. Historically, it looks like the eastern channel flowed further north, but still dissipated as evident in 1943 aerial photograph. The western channel was evident in this 1943 aerial, but also dissipated prior to the Great Salt Lake. Also, both channels terminated in this general area on the 1960 USGS quadrangle map. Therefore, the 3,996 linear feet (0.57 acre) of ephemeral channel are intrastate isolate waters that do not connect with the Great Salt Lake, the nearest TNW.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
