Explain: The 30.52 acre study area is located east of the Feather River, with the Feather River East Levee forming the western study area boundary. The project area extends from the levee crest to 50 ft beyond the landside levee toe from the southernmost section of the Feather River East Levee to approximately Ellis Road.

Topography within the study area slopes gently from the northwest to the southwest, with a 0 to 2 percent change in grade. The natural hydrology of the site has been significantly impacted from past agricultural activities. Agricultural land, totaling 8.44 acres in the study area, is present along the landside toe of the levee. Orchard crops are the dominant agricultural land use in the study area. A total of 3 ditches were identified in the January 2020, delineation Map prepared by GEI consultants. Ditch 1 (STA 2609+75) is 12 linear feet (54 square feet), Ditch 2 (STA 2609+25) is 8 linear feet (30 square feet), and Ditch 3 (STA 2625+40) is 67.5 linear feet (271 square feet). The ditches along the north side of Silva Avenue and the south side of the unnamed agricultural road terminate in a culvert that penetrates the levee. The area waterside of the levee was inspected for evidence of wetland hydrology or an OHWM, indicative of a linear aquatic feature. However, no evidence of flow was observed waterside of the levee. Additionally, the ditches do not exhibit evidence of flow, either directly or through another water. The ditches appear to allow water to infiltrate into the ground, rather than convey flow across the landscape. The ditches do not exhibit an ordinary high water mark (OHWM), therefore are not aquatic resources subject to jurisdiction.

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The preamble for 33 CFR 328.4, published in Federal Register Volume 51, Number 219, published November 13, 1986 (page 41217), states "Limits of Jurisdiction. Section 328.4(c)(1) defines the lateral limit of jurisdiction in non-tidal waters as the ordinary high water mark provided the jurisdiction is not extended by

the presence of wetlands...Corps jurisdiction also stops when the ordinary high water mark is no longer perceptible." In this case the ditches lack characteristics of bed and banks and ordinary high water mark as defined in 33 CFR 328.3(e). As such, the Corps has determined that the aquatic resources within the project area are not potential wetlands or other waters of the United States subject to Corps jurisdiction
