Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The 3.1-acre study area is located north on Beal Air Force Base and approximately 6 miles east of the confluence of the Feather and Yuba Rivers. The natural hydrology of the site has been significantly impacted from past agricultural activities. A total of 155 linear feet (0.08 acre) of drainage ditch (Canal-2) and

99 linear feet (0.007 acre) of roadside ditches (STA 132+0, and STA-161+75), were identified in the January 2019, delineation Map prepared by GEI consultants. Based on historic topography and aerial imagery, Canal-2, appears to have been excavated in uplands circa 2006. In addition to being excavated in uplands, canal-2 is used for agriculture and drains the water from the adjacent rice field and during storm events. The water within Canal-2 remains stagnant, has no flow, and infiltrates to groundwater. It is not a tributary because it does not have direct nor indirect flow into a navigable water. Based on the available information, without the use of artificial irrigation, a prevalence or dominance of hydrophytes would not occur in any location on-site, and the water delivery ditches on-site would not be subject to precipitation volumes that could result in ordinary high water mark indicators. The hydrology is primarily artificially driven and is derived from the adjacent rice field where it infiltrates to ground water.

The roadside ditches are discontiguous and do not exhibit an ordinary high water mark (OHWM). These ditches receive artificial water from the adjacent farms and the occasional runoff from the storm events.

The irrigation for Canal-2 and the roadside ditches were created wholly in uplands and draining only uplands and have no physical connection to a tributary or water of the United States. As such, the Corps has determined that the aquatic resources on site are not potential wetlands or other waters of the U.S. subject to Corps jurisdiction.

C. SIGNIFICANT NEXUS DETERMINATION

B. ADDITIONAL COMMENTS TO SUPPORT JD: The project area contains 155 linear feet (0.08 acre) of drainage ditch (Canal-2) and 99 linear feet (0.007 acre) of roadside ditches. The preamble for 33 CFR 328.3, published in Federal Register Volume 51, Number 219, published November 13, 1986 (page 41217), states "(f)or clarification, it should be noted that we generally do not consider the following waters to be Waters of the United States...(a) Non-tidal drainage and irrigation ditches excavated in dry land and (b) Artificially irrigated areas which would revert to uplands if the irrigation ceased." Canal-2, Roadside Ditch-STA 132+00, and Roadside Ditch-STA-161+75 are ditches that are excavated wholly in uplands, drain only uplands, and have less than perennial flow. These ditches do not contribute flow, either directly or through another water. Without the use of artificial irrigation, Canal-2 would revert to upland. Under 33 CFR 328.3(a)(5), the drainage ditches are not considered tributaries because they do not have direct nor indirect flow into a navigable water. No hydrologic connection could be established between these canals and other nearby waters. As such, the Corps has determined that the aquatic resources on site are not waters of the U.S. subject to Corps jurisdiction
