Explain: **The study area is comprised of 2.5 acres located at the base of the Harmony Mountains and Quichapa Canyon. The study area is located within an arid juniper forest and Quichapa Creek bisects the site. Quichapa Creek is an intermittent channel that flows from the southwest to**

northeast. This Creek originates approximately 3.75 miles to the southwest and is ephemeral in the upper reach. The main channel within the project area is approximately 168 linear feet (0.11 acre), and has sporadic areas of willows, sedges and semi-aquatic vegetation. The ephemeral side channel is located south of the main channel and is approximately 140 linear feet (0.07 acre) and does not contain any riparian plants. These channels converge approximately 100 feet downstream of the eastern study area boundary. From the confluence the channel flows northeasterly and eventually dissipates prior to 7700 West, approximately 2.3 miles from study site. During and post severe rain and snow events, there is potential of overland flow connecting with a concrete ditch east of 7700 West. This ditch flows north and empties into an upland swale which flows east and empties into the Quichapa Lake, a terminal lake. Between the Quichapa Creek dissipation point west of 7700 West and the western edge high water mark of Quichapa Lake is approximately 0.5 miles. The 168 linear feet (0.11 acre) of intermittent drainage and the 140 linear feet (0.07 acre) of ephemeral drainage are intrastate, isolated features with no interstate or foreign commerce connection. Also, Quichapa Lake is an intrastate isolated feature with no interstate or foreign commerce connection (See below for further explanation on no interstate connection and Quichapa Lake details).

The intermittent and ephemeral drainage that bisects the study area are not associated with any foreign or interstate commerce. These waters do have a connection with Quichapa Lake, a seasonal water body. Quichapa Lake is a natural terminal waterbody, which is typically inundated between winter and late summer. Lake dimensions are approximately 4.3 miles long and 1.2 miles wide with a maximum depth of approximately 14 feet. The lake is surrounded by private land, mainly comprised of agricultural uses with a few public access points. There are no associated fees with the access points and no information could be found concerning outfitters using the area for recreation, including hunting and fishing. A few websites were found related to Quichapa Lake and hunting/fishing, but details were vague considering the types of hunting/fishing. One website detailing birding opportunities was found, but not interstate commerce could be associated with this activity. Although the area may be used for the recreation activities described above, no interstate or foreign commerce could be identified with Quichapa Lake, an isolate lake.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
