Explain: **There are five constructed aquatic features within the study area, composed of portions of two ephemeral ditches (ED-1 and ED-2) and two roadside ditches (RD-1 and RD-2), as well as a concrete and rock lined detention basin. The basin was constructed between August 2017 and April 2018,**

in uplands adjacent to the new Prologis commercial development. ED-1 is the terminal end of a remnant and cutoff irrigation ditch. ED-2, RD-1 and RD-2 were all constructed in uplands adjacent to the highway. The topography of the land slopes to the northeast towards Old River, the nearest TNW, approximately 3.5 miles away. There are no tributaries between the study area and Old River. All five aquatic features are isolated and lack a hydrologic connection to waters of the United States downstream. They are not adjacent to or have a nexus to a traditional navigable water or a non-navigable tributary of a traditional navigable water.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
