Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **Ponds 1 and 2, including their adjacent wetlands, were excavated as part of a Resource Conservation and Recovery Act (RCRA) Hazardous Waste Unit called the Tetra-ethyl Lead (TEL) Weathering Area. Since the area was excavated and the soil removed in the 1990s it has become a low point in the surrounding area and has collected stormwater. Since being excavated and graded, the shallower portions of Ponds 1 and 2 developed wetland soils and vegetation characteristic of an emergent marsh. Stormwater enters the TEL Pond Area**

from a culvert on the east side of Pond 1 and as runoff from the adjacent roads and hardscaped areas. Pond 2 is connected to Pond 1 by a culvert in the central portion of the TEL Pond Area. The entire TEL Pond Area is isolated from other waters surrounding the project site. The hydraulic gradient is from the TEP Pond Area to the west and southwest. The western side of Pond 1 is bordered by a clay cutoff wall that prevents any subsurface flow from entering the Oil Drain Canal. Additionally, Chevron has relocated the Oil Drain Canal approximately 800 feet to the west. The old alignment of the Canal was to be backfilled with clean fill. Therefore the TEL Pond Area is isolated from the Oil Drain Canal. The southern border of Pond 1 is a berm and access road that separates it from Pond 3 which is outside of the review area of this jurisdictional determination. The berm and access road are constructed from the native soil which has very low hydraulic conductivity. These native soils are also further compacted through the construction and use of the access road. The native soils have an in-situ hydraulic conductivity on the order of 0.000005 cm/sec. Therefore, any subsurface connection between the TEL Pond Area and Pond 3 is indiscernable.

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** In 2014 Chevron requested an approved jurisdictional determination for the 11.2 TEL pond area. The Corps verified this determination on September 22, 2014. At the time, Pond 1 and associated wetland equaled 5.3 acres. After the Corps determined these waters were not jurisdictional, Chevron altered the site to

construct the TEL pond Segregation site for storm water management for the facility. The western section of Pond 1 has been filled with riprap boulders while the east side of Pond 1 maintains its original configuration. However, conveyance structures will eventually be constructed near the southwest corner of the west pond. These could include inlet structures, granular activated carbon stations or other engineered controls to regulate inflow of water from within the refinery area. The TEL segregation site is limited to Pond 1 only.
