Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **The potentially jurisdictional water labeled "Roadside Ditch" is an approximately 0.01 acre man-made feature that was constructed in upland, and drains only upland. This aquatic feature does not meet the definition of "Waters of the United States." First, this feature encounters infrequent, low volume, flows, and is ephemeral in nature. Secondly, based on historical photos, it appears this feature was excavated wholly in, and drains only upland. Furthermore, this feature does not carry a relatively permanent flow of water. 33 CFR Section 328.3: Definitions, states that we generally do not consider the following to be "Waters of the United States." (a) Non-tidal drainage and irrigation ditches excavated on**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The study area contains a 6-foot-wide roadside ditch that receives flow from a residential development south of the delineation area. The roadside ditch conveys urban runoff into the City's stormwater system and may eventually connect (through subsurface and surface connections) to South Branch Pleasant Grove Creek. Based on historic aerials, the roadside ditch was excavated in upland for the purpose of conveying street runoff, and drains only uplands.
