<sup>2</sup> Some excluded waters, such as (b)(2) and (b)(4), may not be specifically identified on the AJD form unless a requestor specifically asks a Corps district to do so. Corps districts may, in case-by-case instances, choose to identify some or all of these waters within the review area.

<sup>3</sup> Because of the broad nature of the (b)(1) exclusion and in an effort to collect data on specific types of waters that would be covered by the (b)(1) exclusion, four sub-categories of (b)(1) exclusions were administratively created for the purposes of the AJD Form. These four sub-categories are not new exclusions, but are simply administrative distinctions and remain (b)(1) exclusions as defined by the NWPR.

**C. Additional comments to support AJD:** [A review of ariel imagery and photographs provided by the applicant demonstrate the presence of a seasonal wetland within the project site. Photographs provided in the Wetland Delineation report, dated March 15, 2019, show linear furrows running north to south through the wetland and some remnant irrigation. Historic aerial imagery shows that the seasonal wetland area may have been used for agriculture in the past, and it is currently surrounded by residential development since at least 1993. This wetland is approximately 0.5 miles from the nearest a\(1\)-a\(3\) waters and thus is not considered an adjacent wetland.](#)
