#### C. Additional comments to support AJD:

This review area includes a ditch network comprised of features SPK200701801.DD1-E. SPK200701801.DD2-E, SPK200701801.DD3-E, SPK200701801.DD4-E, SPK200701801.DD5-E, SPK200701801.DD6-E, SPK200701801.DD7-E, SPK200701801.DD8-E, SPK200701801.DD9-E, SPK200701801.DD10-E, SPK200701801.DD11-E, SPK200701801.DD12-E, and SPK200701801.DD13-E. The 1910 USGS mapping of the area indicates two streams crossing the review area from the northeast to the southwest but do not show these streams continuing beyond Section 34, Township 11 North, Range 4 East. By October 6, 1937 the Natomas East Main Drainage Canal had been constructed just to the east of the site across these stream channels and intercepting their upstream flow. By the 1950's, ditch construction had begun in the review area and a north-south ditch intercepted whatever was left of the flow of these streams at the western edge of the review area. Following this ditch south it eventually discharged to the East Drainage Canal, then to the Natomas Main Canal and then into the Sacramento River (USGS, Verona, CA, 1952; USGS, Davis, CA, 1954; and USGS, Fair Oaks, CA, 1954). By 1971 much of the ditch network considered here had been constructed and rice cultivation was underway centered roughly on the flow path of those historic streams. Contour rice checks, or low berms, are visible in Field 11 and the fields with rice cultivation are very dark compared to surrounding areas indicating inundation or saturation through irrigation. While it is possible that one or more ditches relocated the streams depicted in the 1910 maps and connected those streams to downstream waters it is not clear that these streams existed at the time of ditch construction or that these streams would have met the flow requirements of the tributary definition under current regulation. The construction of the Natomas East Main Drainage Canal and its position intercepting the flow of these streams before they reach the site is compelling evidence suggesting that natural flow duration and frequency was reduced prior to the construction of the ditch network. Based on the best information available to us we conclude that the ditch network did not relocate a tributary and was not constructed in a tributary consistent with today's definition of that term.

Areas with signatures consistent with wetlands are visible in the 1937 image, some of which are closely associated with the two streams and in areas that are now crossed by the ditch network. However, since the evidence available to us suggests that these streams would not have met today's definition of tributary the wetlands would not have been adjacent by today's definition of adjacency at the time the of ditch construction.

As we find it today, the ditch network is perennial, supported by irrigation water pumped from groundwater as well as providing drainage for the rice fields during the period between cultivation and irrigation cycles.

The wetlands included here in the irrigated areas either did persist in the absence of irrigation in the case of fields 2, 4 and 11 (ESA, 2020) or would persist in the absence of irrigation in those fields where irrigation continued uninteruped (Robb, 2017). Wetlands in this review area are near and in many cases abut or are separated only by artificial barriers and structures from the ditch network and in many cases are periodically inundated by flooding from these ditches for the purpose of rice cultivation. Natomas East Main Drainage Canal, which is also called Steelhead Creek, is near the eastern boundary of the site and may be a relocated



tributary. However, none of these wetlands abut Steelhead Creek nor are they separated only by an artificial or natural barrier from Steelhead Creek and Steelhead Creek does not flood any of these wetlands in a typical year. Even if the water from the canal were used for flood irrigation it would be delivered via the non-jurisdictional ditches and not directly from Steelhead Creek. (Irrigation source water is groundwater in these fields, see Robb, 2017). There are no other waters nearby to which these wetlands could be adjacent. Since we find here that the ditches of this ditch network are not tributaries pursuant to 33 CFR 328.3(c)(12) the wetlands within the review area are not adjacent wetlands.
