The 12-acre review site is located on the north end of Utah Lake and the subject wetlands are approximately 750-feet north of the Utah Lake ordinary high-water mark. The wetlands are separated by a historic ditch that no longer flows. This ditch does not exhibit an ordinary high-water mark and is believed to be constructed to dewater this wetland and wetlands to the north. The ditch within the property was constructed sometime between 1947 and 1958. The subject wetlands are fed by a high groundwater table and flood irrigation. Historically the property was an agricultural field. Then was abandoned sometime in the late 1990's and became a monoculture of Russian Olive. The current landowner removed the Russian Olive around 2016. Aerials analyzed focused on wet years and the only year that the Utah Lake inundated the subject wetlands was 1983 which is well above 100-year event and is not typical. Currently, the subject wetland waters do not have a direct surface connection with Utah Lake the nearest (a)(1) water. Therefore, these wetlands within the 12-acre review area are not waters of the U.S. regulated under Section 404 of the Clean Water Act or under Section 10 of the Rivers and Harbors Act.
