  - The review area is comprised entirely of dry land (i.e., there are no waters or water features, including wetlands, of any kind in the entire review area). Rationale: The property encompasses approximately 1.4 acres of undeveloped land. A review of aerial imagery dating back to September of 1998, in conjunction with a Natural Resource Conservation Service (NRCS) Web Soil Survey and the US Fish and Wildlife Service's National Wetland Inventory show that the project area has been highly disturbed and lacks wetland hydrology and vegetation. The areas immediately west and south of the project area and to the east on the other side of 100 East all appear to contain wetlands through the NRCS Web Soil Survey, USFWS National Wetland Inventory, and aerial imagery. However, the lack of wetland signatures within the project area indicates that all proposed work would occur in uplands.
