**Wetland 04 is less than 0.01 acre and is part of a small, isolated depression dominated by inland saltgrass. It may be the result of past excavation activities. Wetland 04 is not contiguous with any of the other larger wetlands documented on site (Wetlands 01, 02, 03, 05, and 06) identified in the delineation report and evaluated in a separate JD form.**

Wetland 04 was determined to be an intrastate isolated aquatic resource with no apparent interstate or foreign commerce connection because it is part of a closed, isolated depression that does not connect to the North Temple Ditch, which is the closest relatively permanent water that flows into the Great Salt Lake.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

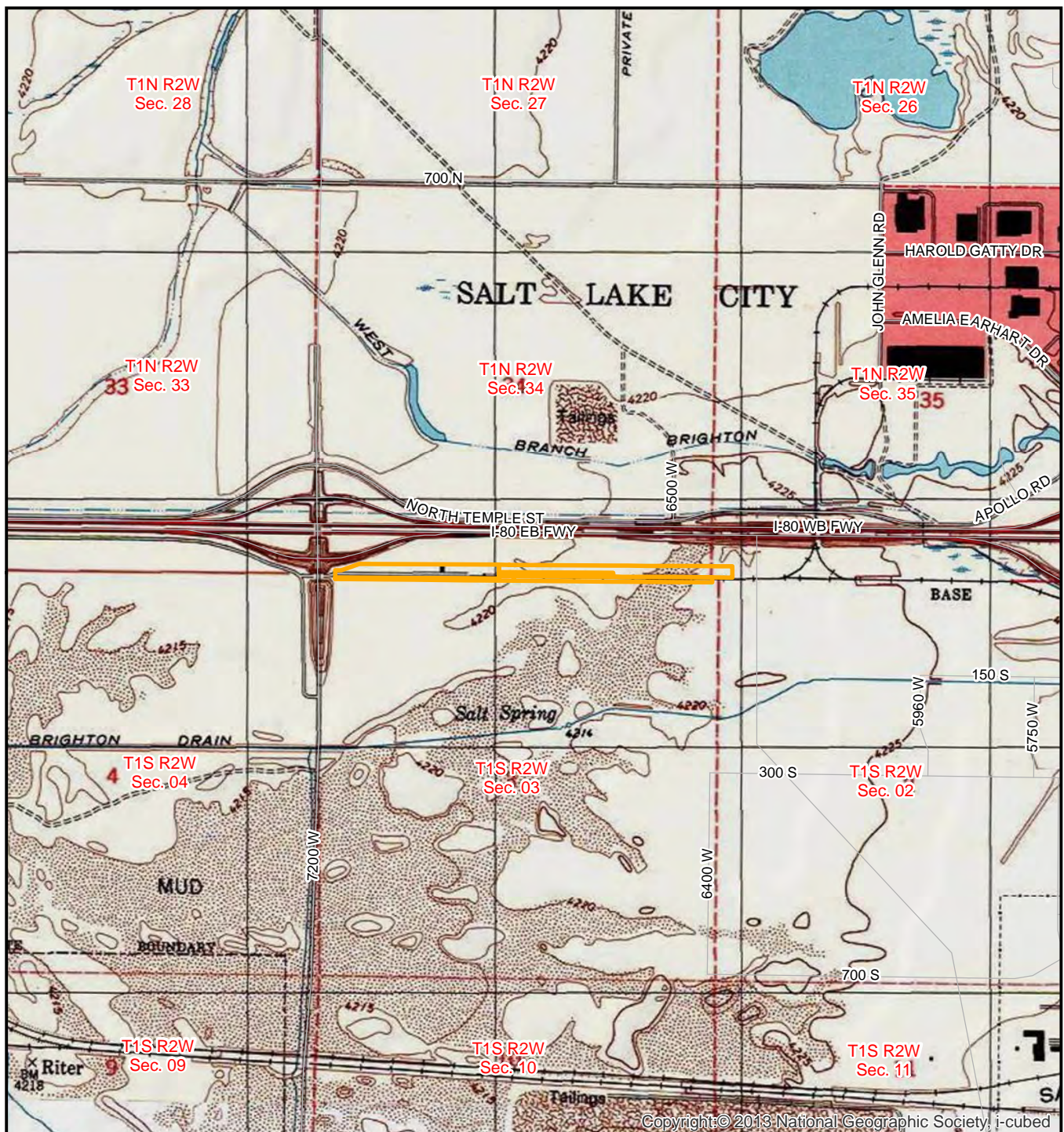

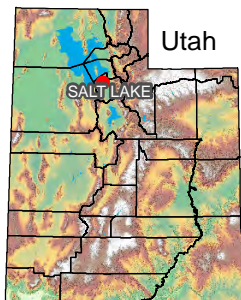
**B. ADDITIONAL COMMENTS TO SUPPORT JD: The study area is being investigated for an enforcement action in which waters of the U.S. were filled for the construction of existing rail lines and fill material was discharged on top of the natural soil surface without the required Department of the Army (DA) authorization. In 2015 Salt Lake Garfield & Western imported approximately 4,291 cubic yards of fill for construction of rail lines with the purpose of transloading and storage. Evidence of these past fill activities that have impacted aquatic resources can be seen in historic aerial imagery. A rail line interchange, identified as the West Interchange, is being planned in close proximity to the unauthorized activity (UA) fill area. Based on information submitted by the applicant and consultant, the UA fill subject to this AJD, the use of the transloading and storage facility is**

inconsistent with the use of the future West Interchange and the Corps has determined that the UA work and the future West Interchange have independent utility. Therefore, the UA fill and potential impacts to aquatic resources associated with the future West Interchange will be evaluated under separate DA authorizations.
