**2. Non-regulated waters/wetlands (check if applicable):<sup>3</sup>**

Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The wetlands and pond on site are isolated features with no surface or shallow sub-surface connection to other aquatic features. Wetland 1 (0.19 acre) continues off-site to the south where the actual extent has not been documented. However, an upland berm contains surface water and prevents the wetland from extending to the west (down gradient). Wetland 1 is bordered on the south and east by development.

The Pond (0.2 acre) and Wetland 2 (0.2 acre) were historically supported by an artesian well that was mostly shut off in May 2020. A small amount of water is still leaking immediately around the well head. The wetland finger protruding south extends to the south study area boundary, where it historically connected to a drainage ditch

feature flowing west and potential off-site wetlands on the adjacent south lot. That ditch has long since been partially filled (date unknown) and the remaining open ditch does not convey water or have OHWM indicators. There are no other on-site or off-site connections from the Pond and Wetland 2 to other aquatic features.

Wetland 3 (0.41 acre) is wholly contained within the study area and was historically supported by irrigation ditches that carried water from the artesian well. The ditches no longer function and do not have OHWM indicators, and the well was mostly shut off in May 2021. As a result, Wetland 3 has been drying out. There are no on-site or off-site connections from Wetland 3 to other aquatic features.

Historic irrigation and drainage ditch features are shown in orange on the delineation map, but these features have been abandoned and have no OHWM indicators.

All aquatic features on site are isolated, intrastate waters with no interstate or foreign commerce connection. Therefore, the Corps has determined that these features are not regulated under CWA Section 404.

**C. SIGNIFICANT NEXUS DETERMINATION**

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**
