C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The Antecedent Precipitation Tool (APT) was used to give context to this site based on the aerial photos dated February 14, 2017 and February 26, 2017 (Digital Globe Images). The APT indicated at the time of the image the study area was experiencing wetter than normal conditions, and the drought index PDSI was indicating extreme wetness, and it was during the wet season. Based on the conditions during the time the aerial phot was taken, there is a lack of hydrology flowing out of SW-8, SW-10, SW-11, VP-1, and VP-2.

VP-2 has a downward slope which flows to the Northwest into VP-1 and has hydrologic connectivity to VP-1, however VP-1 is topographically isolated and has a ridge around it approximately that varies 1-4 feet high. There is no evidence of a subsurface connection. There were transects taken between VP-1 and SW-6, which appeared to have been moist on the sides at 22 inches, however it did not meet saturation definitions. Therefore VP-1 and VP-2 are isolated, intrastate waters with no interstate or foreign commerce connection.

SW-8 has a downward slope to the South into SW-10, and SW-9 has a downward slope East into SW-10. However, SW-10 is topographically isolated as SW-10 is in a depression that is approximately three feet high. Ponding occurs in the wetland and does not flow out. There is no evidence of a subsurface connection. Therefore, these waters are isolated, intrastate waters with no interstate or foreign commerce connection.
