Dotentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The study area contains only man-made irrigation ditch features, and no other aquatic features are present on-site. The site contains several small irrigation ditches used to distribute water at the Project Area for pasture irrigation. None of the ditches were documented to have Ordinary High-Water Mark (OHWM) indicators or evidence of semipermanent flows. Based on information provided by the environmental consultant, the only source of water for the pasture fields is flood irrigation water originating from the Layton Canal that is delivered by the irrigation ditch at the northern boundary of the Project Area. Other ditches are used to spread the water over the pasture field. No other evidence of surface water from other sources was documented anywhere within the Project Area. The ditches have no apparent

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. #### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g., between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
