Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The 3.3-acre project site contains 0.25 acre of aquatic features consisting of 0.22 acre of riparian wetland (RW1) and 0.03 acre of constructed roadside ditch (CD2). The wetland on site, RW1, is an isolated feature with no discrete surface or shallow sub-surface connection to other aquatic features. The soils on site are not likely to support a shallow aquitard or lateral sub-surface connection, as they are primarily sands. The wetland is contained within the study area with a berm on the North side and appears to be supported by a nearby spring from the South side. Given that the wetland is isolated and is an intrastate water with no interstate or foreign commerce connection and has no surface or subsurface connection to a RPW or TNW, the Corps has determined that the aquatic feature is not regulated under the CWA Section 404.

CD2 is a man-made roadside ditch within the study area, which flows through a culvert within the project area and dissipates in an upland residential area north of the study area. The ditch does not have a clear Ordinary High-Water Mark and does not connect to other waters. This feature is an ephemeral ditch, which flows due to precipitation events (not a relatively permanent water), that is not a relocated tributary or excavated in a tributary (excavated wholly in upland); furthermore, this feature does not contribute flow to a TNW and is therefore not considered jurisdictional.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: A field visit on April 25, 2022, did not reveal any surface water flow between the wetland (RW1) and the roadside ditch (CD2). There was also a noticeable difference in vegetation between the mapped wetland area and the rest of the upland habitat surrounding the wetland, suggesting that the wetland was isolated. The wetland is also within a slight depression. The geotechnical investigation of the site included borings near the road and did not find evidence of a shallow aquitard or soils appropriate for lateral flow.
