Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain:

An approximately 0.22-acre storm water detention basin was constructed in the northern portion of the project site in 2006-7. This feature was constructed in an area that appears to have flooded as a result of the mass grading associated with the construction of the residential development (SPK-2003-00349) located directly west of the study area; however, this area appears to have been uplands prior to the start of work. For more details, reference document in the file titled 2022.06.21 - Google Earth for AJD - 202100332. Additionally, two data points recorded in within the detention basin on February 23, 2021, did not record the presence of wetland hydrology, hydric soils, or a plant community dominated by

hydrophytes. Additionally, no ordinary high water mark was noted. See document in file titled 2021.09.22 - JD Wildhorse Road Final 202100332.

Though this feature was constructed as a detention basin, it does not represent a potential water of the U.S. This conclusion is consistent with 33 CFR §328.3(c)(16), the 1987 *Corps of Engineers Wetlands Delineation Manual* (Wetlands Research Program Technical Report Y-87-1) and the applicable regional supplements; the location and boundaries of tidal waters conform with the high tide line defined at 33 CFR §328.3(c)(4); and the location and boundaries of non-tidal waters conform with the ordinary high water mark definition at 33 CFR §328.3(c)(7), Regulatory Guidance Letter 05-05, and any applicable regional guide.

A small reach (0.001 ac. / approx. 20 linear feet) of concrete-lined drainage ditch enters the northernmost portion of the project area before flowing into an underground stormwater drainage system by way of a storm drain located on-site. Based on available information, we have determined that the concrete-lined drainage ditch is not a water of the U.S. The ditch appears to have been excavated wholly in uplands, drains only uplands, and does not carry a relatively permanent flow of water. As such, there are no waters of the U.S. present within the study area subject to potential jurisdiction under Section 404 of the Clean Water Act or Section 10 of the Rivers and Harbors Act of 1899.

It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g., between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
