**Isolated Feature: Wetland A** – This 0.14-acre wetland is situated in an excavated linear depression that is approximately one foot lower in elevation than the surrounding ground. The Aquatic Resources (AR) report prepared by Frontier Corporation USA, indicates that the depression appeared to be purposefully created to capture and retain water from a nearby artesian well and was used for livestock watering.

In 2016, Kagel Environmental, LLC completed a 1,864-acre aquatic resources delineation that covered a larger land area (known then as the Epperson Project site) that includes the 194.42-acre subject study area.

Wetland A is located in an area identified in the 2016 AR report as D33-5, a 153-foot-long ditch classified as a perennial Relative Permanent Water (RPW) flowing directly or indirectly into Traditional Navigable Water (TNW). At the time of the 2016 delineation, the site was being irrigated and D33-05 was fed by water from the West Branch Brighton Canal, located near the northeast corner of the study area. The canal was decommissioned in 2019 and the study area has not been irrigated since. The fieldwork for the subject delineation done in May 2021 documented the current site conditions after two growing seasons since the permanent removal of irrigation water from the site. Features identified as jurisdictional waters of the U.S. documented in 2016 no longer exist due to the removal of canal water. The only source of surface water on the site is a free flowing artesian well that provides hydrology to Wetland A, which is an isolated man-made feature with no natural or man-made tributary connections to the Great Salt Lake, the closest TNW.

Given that Wetland A is isolated and is an intrastate water with no interstate or foreign commerce connection and has no surface or subsurface connection to a Relative Permanent Water or a Traditional Navigable Water, the Corps has determined that the aquatic feature is not regulated under the CWA Section 404.

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The previous Approved Jurisdictional Determination (AJD) verification included 1,864 acres and was broken-up into four parcels, Parcels 17, 29, 32, and 33. USACE verified that the study area contained approximately 141.58

acres of saline wet meadow, 76.3 acres of playa, and 18,292 linear feet of channels that were determined to be jurisdictional under Section 404 of the Clean Water Act and 8,857 linear feet of irrigation ditches that were determined to be non-jurisdictional waters. The subject study area is the northern half of Parcel 33 of the Epperson Project AJD.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The 2016 delineation identified feature W-33-5 as a wetland directly abutting an RPW that flow into the Great Salt Lake. This area was re-evaluated by Frontier Corporation USA on May 2021. Although the site supported a 5% cover of Facultative-Wet vegetation (*Suaeda occidentalis*), this area lacked indicators of soils and wetland hydrology and was determined to be an upland. The changes in this area of the property can be attributed to the decommissioning of the West Brighton Canal.
