Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The approximately 0.59-acre aquatic resources study area is a small portion of a linear safety project to improve the entrance/exit of traffic from the Valley Oaks Shopping Center onto State Route (SR) 12. The surrounding land use is dominated by the Valley Oaks Shopping Center parking lot, a real estate office parking lot, and SR 12. The study area contains a single 0.16-acre roadside drainage ditch, Ditch 1, a non-tidal roadside ditch constructed entirely in uplands and draining only uplands. Ditch 1 receives runoff from SR 12 and the two parking lots. It does not carry a relative permanent flow of water and is not a relocated tributary. The roadside ditch is not considered jurisdictional.

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
