Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain:

Mabey Pond: Aerial imagery shows that Mabey Pond was constructed, either by excavation or impoundment, prior to 1953. The pond is a 3.13-acre excavated feature that currently functions to store stormwater runoff for adjacent developed areas. A municipal stormwater drain along the east side of the pond was documented during the aquatic resources survey as the only source of hydrologic input to the pond. In addition, Clearfield City park staff periodically adds water to the pond to maintain water levels.

No streams, creeks, or irrigation canals, or other upstream/downstream surface water connections to Mabey Pond were identified in the aquatic resources report submitted for this review or during USACE's desktop analysis.

Maps and historic aerial records confirm that Mabey Pond has no connection to any other drainage features or any jurisdictional waters on or off site, no apparent connection to interstate or foreign commerce or direct/indirect connection to the Great Salt Lake, the the closest TNW; therefore, USACE has determined Mabey Pond to be a non-jurisdictional feature.

The subject AJD request is associated with an upland development that borders the pond for approximately 454 linear feet of lakeshore as depicted in Attachment 1. However, this determination includes the entire 3.13-acre pond.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Review of the US Fish and Wildlife Service Wetland Mapper indicates that a possible connection to an approximately 1.24-acre wetland feature, listed as PSS/EM1A (Palustrine Scrub-

Shrub/Emergent, Persistent, Temporary Flooded), along the northern boundary of Mabey Pond. This wetland feature has been subject to urban/residential development between 1997 and 2004 and is no longer present.
