Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **Four palustrine emergent wetlands and one pond were determined to be isolated with no interstate commerce. The subject waters are SW-1 (0.27 acre), WS-1 (0.009 acre), WS-2 (0.098), WS-3 (0.041 acre), and Pond-1 (0.07 acre). The main hydrologic sources for these wetlands is irrigation and stormwater runoff.**

- **The SW-1 and Pond are located approximately 275 feet south of a perennial irrigation ditch that flows to the east. These features are depressional and the ditch has a 1-2 foot berm. There is no hydrologic**

connection between the wetland and pond and the ditch, due to the depressional nature of the wetland, length of dryland between wetland to ditch, and the berm around the ditch.

- WS-1 terminates in an agricultural field, approximately 217 feet west of an offsite wetland. The dryland between WS-1 and the offsite wetland, includes an access road that is 1-2 feet higher that would prevent any hydrologic connection.
- WS-2 does not have a hydrologic connection with the wetland located approximately 45 feet east. The wetland terminates just before the access road that prevents any hydrologic connection.
- WS-3 terminates prior to the access road and is separated from the offsite wetland to the east approximately 100 feet of dryland separation. No hydrologic connection could be identified to the wetland to the east.

In addition, the nearest downstream RPW for WS-1, WS-2, and WS-3 is located at least ½ mile to the northeast. No hydrologic connection was identified between these wetlands and the offsite wetland to the east. The offsite wetland does connect with the RPW to the northeast. The wetlands and pond within the site are located approximately 2 aerial miles from Carson River, the nearest TNW. No hydrologic connection could be made between SW-1, Pond, WS-1, WS-2, and WS-3, and the Carson River, nearest TNW. No interstate or foreign commerce could be connected to these waters. Therefore, these waters were determined to be isolated and non-jurisdictional.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. **C. SIGNIFICANT NEXUS DETERMINATION**

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**
