**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

A preliminary Jurisdictional Determination (PJD) that included W-1 (identified as W-25 in the PJD) in addition to all other waters within the Mountainview Corridor footprint was verified on February 6, 2009. An Approved Jurisdictional Determination (AJD) that included W-1 (identified as W-25 in the AJD) in addition to 3 other wetland areas within the footprint and adjacent to the recently constructed Mountain View Corridor. The 3 wetlands were found to be isolated since they had no hydrologic connection with the nearest RPW, Utah and Salt Lake Canal. The AJD was verified on September 11, 2012.
