The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.



B. ADDITIONAL COMMENTS TO SUPPORT JD: These agricultural basins are interspersed within agricultural lands and total 2.31 acres. Based on the aerial photographs from GoogleEarth and the information provided in the delineation, the agriculture basins (labeled AB-01, AB-02, AB-03) do not have a connection to downstream aquatic resources. These agricultural basins are lower than the surrounding area, and there is no nexus to other waters or wetland features. Two of the three basins meet wetland criteria, but do not drain off-site and are considered isolated waters. None of the wetlands have a direct surface connection to other waters and are not used to transport interstate commerce. They are also not considered jurisdictional features based on the guidance in 33 CFR 328.3(b). Field information was gathered by Rincon Consultants, Inc.
