A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. - B. ADDITIONAL COMMENTS TO SUPPORT JD: These seasonal wetlands are functioning on a previously disturbed landscape. These wetland features total 0.177 acres in size. Based on the aerial photographs from GoogleEarth and the information provided in the delineation report, these wetlands do not have a connection to downstream aquatic resources. These seasonal wetlands are located in depressional areas that have lost their connection to the nearest stream, Little Indian Creek. These features meet wetland criteria, but do not drain off-site and are considered isolated waters. None of the wetlands have a direct surface connection to other waters and are not used to transport interstate commerce. They are also not considered jurisdictional features based on the guidance in 33 CFR 328.3(b). Field information was gathered by Madrone Ecological Consulting, March 2022.
