**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

#### **B. ADDITIONAL COMMENTS TO SUPPORT JD:**

The Corps verified a Nationwide Permit (NWP) 14 request on March 21, 2017, for the Meyers Stream Environmental Zone/ Erosion Control Project (CIP #95179), SPK-2016-00443. A small portion of the current project area was located within the NWP project area. The NWP request included a 2015 delineation report by NCE (Delineation of Waters of the United States Meyers ECP – Expanded Area (+/- 35 Acre Survey Area)) which identified the Apache Ditch as a non-federally jurisdictional ditch labeled "10". The Corps verified the permit request, thereby concurring with the 2015 delineation report by default. Additionally, the October 8, 2021 delineation report included two OHWM Datasheets for the project area between Apache Avenue, south of E San Bernardino Avenue and north of Sioux Street. The delineation field investigation was unable to find an upstream connection for Apache Ditch, concluding this portion of Apache Avenue is the most upstream portion of the ditch system. The OHWM Datasheets also indicated the ditch did not have any OHWM indicators. From all data submitted by the applicant, it appears the

feature was constructed in uplands for the purposes of stormwater management and does not carry a relatively permanent flow to a downstream TNW or a tributary to a TNW.
