Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: Two wetland features (W01 and W02) and 2 channel features (Fremont Wash and Cottonwood Wash) were identified within the study area. Several erosional features were also evaluated and determined to have no OHWM indicators. The wetland features are supported by seasonal and temporary surface water from storms and snow melt, as well as minor ground water expression during wetter periods. Both wetlands

are isolated features, with no upstream or downstream connections to other aquatic features and are surrounded on all sides by uplands. The OHWM indicators in Cottonwood Wash disappear within the study area due to confined flow spreading out into sheet flow as gradient flattens. Fremont Wash maintains OHWM indicators throughout the study area and offsite until it reaches the Little Salt Lake, an endorheic (hydrologically closed) basin approximately 4 miles southwest of where Fremont Wash exits the study area boundary. Little Salt Lake is a closed drainage basin with no surface water most of the time and no historic outlet, though the pre-historic outlet was through Parowan Gap to the west. The lake level would have to rise an estimated 16-20 feet in order to drain through Parowan Gap, which would only drain toward the northwest through a series of dry channels and eventually into another closed drainage basin- Sevier Dry Lake. The Corps has determined that the 2 wetlands and 2 channels within the study area are isolated, intra-state waters with no interstate or foreign commerce connection. As such, these waters are not currently regulated under CWA Section 404.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
