Explain: Three wetland features (W01, W02, and W04) totaling 11.94 acres, one open water stock pond (W03) totaling 0.34 acre, two ephemeral channel features (EC01 and EC02) totaling 10,750 linear feet, and one irrigation canal totaling 1,577 linear feet were identified within the study area. Several erosional features and upland swales were also evaluated and determined to have no OHWM indicators.

EC02 converges with EC01 on site near the northern boundary, then flows off site to the north and drains into the Rush Lake closed basin. The wetland features are supported by seasonal and temporary surface water from storms and snow melt, as well as minor ground water expression during wetter periods. All three wetlands are isolated features, with no direct or indirect downstream connections to a TNW. W01 extends offsite to the west but is surrounded by uplands. W02 is located along the EC02 drainage. W03 is an isolated, man-made stock pond surrounded by uplands. W04 receives flow from the irrigation canal and is otherwise surrounded by uplands.

Rush Lake is an endorheic (hydrologically closed) basin approximately 2.5 miles northeast of where EC01 exits the study area boundary. Rush Lake is a closed drainage basin with no surface water most of the time and no historic outlet. Prehistoric flows or extreme precipitation/flood events would potentially flow to the northwest through Mud Spring Canyon and into the Escalante Desert, through a series of dry channels, and eventually into another closed drainage basin- Sevier Dry Lake. The Corps has determined that the 3 wetlands, 2 channels, man-made canal, and stock pond within the study area are isolated, intra-state waters with no interstate or foreign commerce connection. As such, these waters are not currently regulated under CWA Section 404.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
