Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: Wetland 2 (0.282 acre) is a palustrine emergent wetland that was constructed in 2006 as a detention basin for the Westfield Subdivision. The subdivision plans were developed in 2002 and finalized in 2005. The detention basin collects stormwater through pipes and overland flow from the adjacent street and development. This basin was constructed in dryland which was determined from the review of multiple aerial photographs and the 2005 engineering drawings. Aerial photos were reviewed back to 1959 when the area was

farmed up until around 2006 when the stormwater basin was constructed. Therefore, wetland 2 (0.282 acre) is manmade and was constructed in dryland.

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
