We are responding to your June 20, 2023, request for an approved jurisdictional determination for the San Luis Ranch site. The approximately 296.60-acre project site is located at Latitude 37.090026°, Longitude -121.007695°, Santa Nella, Merced County, California.

Based on available information, we concur with your aquatic resources delineation for the site, as depicted on the enclosed June 20, 2023, *Figure 4-1, Aquatic Resources Delineation Map*, prepared by ICF International Inc. (enclosure 1). There are no aquatic resources present within the survey area. This letter verifies that the location and boundaries of wetlands were delineated consistent with the wetland definition at 33 CFR §328.3(c)(16), the 1987 *Corps of Engineers Wetlands Delineation Manual* (Wetlands Research Program Technical Report Y-87-1) and the applicable regional supplements; the location and boundaries of tidal waters conform with the high tide line defined at 33 CFR §328.3(c)(4); and the location and boundaries of non-tidal waters conform with the ordinary high water mark definition at 33 CFR §328.3(c)(7), Regulatory Guidance Letter 05-05, and any applicable regional guide.

Within the review area, there are no waters of the United States pursuant to 33 CFR Part 328 regulated under Section 404 of the Clean Water Act, and there are no navigable waters of the United States pursuant to 33 CFR Part 329 regulated under Section 10 of the Rivers and Harbors Act.

We are enclosing a copy of the *Approved Jurisdictional Determination Memorandum for Record* for your site (enclosure 2).

This approved jurisdictional determination is valid for five years from the date of this letter unless new information warrants revision of the determination before the expiration date. If you object to this determination, you may request an administrative appeal under Corps regulations at 33 Code of Federal Regulations (CFR) Part 331. A *Notification of Appeal Process (NAP) and Request for Appeal (RFA) Form* is enclosed (enclosure 3). If you request to appeal this determination, you must submit a completed RFA form to the South Pacific Division Office at the following address: Administrative Appeal Review Officer,

In order for an RFA to be accepted by the Corps, we must determine that the form is complete, that it meets the criteria for appeal under 33 CFR Part 331.5, and that the form was received by the Division Office within 60 days of the date of the NAP. It is not necessary to submit an RFA form to the Division Office unless you object to the determination in this letter.

We recommend that you provide a copy of this letter and notice to all other affected parties, including any individual who has an identifiable and substantial legal interest in the property.

The delineation included herein has been conducted to identify the location and extent of the aquatic resource boundaries and/or the jurisdictional status of aquatic resources for purposes of the Clean Water Act for the particular site identified in this request. This delineation and/or jurisdictional determination may not be valid for the Wetland Conservation Provisions of the Food Security Act of 1985, as amended. If you or your tenant are USDA program participants, or anticipate participation in USDA programs, you should discuss the applicability of a certified wetland determination with the local USDA service center, prior to starting work.

NOTIFICATION OF ADMINISTRATIVE APPEAL OPTIONS AND PROCESS AND

SECTION I - The following identifies your rights and options regarding an administrative appeal of the above decision. A: INITIAL PROFFERED PERMIT: You may accept or object to the permit.

- OBJECT: If you object to the permit (Standard or LOP) because of certain terms and conditions therein, you may request

  forfeit your right to appeal the permit in the future. Upon receipt of your letter, the district engineer will evaluate your
  objections and may: (a) modify the permit to address all of your concerns, (b) modify the permit to address some of your
  objections, or (c) not modify the permit having determined that the permit should be issued as previously written. After
  evaluating your objections, the district engineer will send you a proffered permit for your reconsideration, as indicated in
  Section B below.

D: APPROVED JURISDICTIONAL DETERMINATION: You may accept or appeal the approved JD or provide new information.
