MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Approved Jurisdictional Determination in accordance with the "Revised Definition of 'Waters of the United States'"; (88 FR 3004 (18 January 2023) as amended by the "Revised Definition of 'Waters of the United States'; Conforming" (8 September 2023) ,¹ [SPK-2024-00784].²

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.³ AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.⁴

On 18 January 2023 the Environmental Protection Agency (EPA) and the Department of the Army ("the agencies") published the "Revised Definition of 'Waters of the United States,'" 88 FR 3004 (18 January 2023) ("2023 Rule"). On 8 September 2023, the agencies published the "Revised Definition of 'Waters of the United States'; Conforming", which amended the 2023 Rule to conform to the 2023 Supreme Court decision in *Sackett v. EPA*, 598 U.S., 143 S. Ct. 1322 (2023) ("*Sackett*").

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. For the purposes of this AJD, we have relied on Section 10 of

the Rivers and Harbors Act of 1899 (RHA),⁵ the 2023 Rule as amended, as well as other applicable guidance, relevant case law, and longstanding practice in evaluating jurisdiction.

1. SUMMARY OF CONCLUSIONS.

a. The review area is comprised entirely of dry land (i.e., there are no waters such as streams, rivers, wetlands, lakes, ponds, tidal waters, ditches, and the like in the entire review area and there are no areas that have previously been determined to be jurisdictional under the Rivers and Harbors Act of 1899 in the review area). A site visit was performed by the Corps on 20 November 2024 during which the entire review area was visually observed on foot. No aquatic resources were observed.

Additionally, three data points were recorded by [REDACTED] within or near the review area, and none indicated the presence of wetlands or other waters.

3. REVIEW AREA. The approximately 3.78-acre review area is located on the east (left) bank of the Sacramento River in Section 24, Township 7 North, Ranch 4 East, Mount Diablo Baseline & Meridian at Latitude 38.44568°, Longitude -121.49533° in Sacramento County, California and is portrayed on the USGS *Florin, California* 7.5-minute topographic quadrangle. There are no previous jurisdictional determinations identified within the review area. Enclosure 1 is an aquatic resources delineation map (with an inset vicinity map) titled *Aquatic Resources Delineation* prepared by [REDACTED] and dated 7 January 2025. The review area portrayed as "Limit of Work (3.78 acre)."

4. NEAREST TRADITIONAL NAVIGABLE WATER (TNW), THE TERRITORIAL SEAS, OR INTERSTATE WATER TO WHICH THE AQUATIC RESOURCE IS CONNECTED. N/A, the review area supports no aquatic resources. The nearest TNW is the Sacramento River, which is located approximately 0.08 air mile to the west.

5. FLOWPATH FROM THE SUBJECT AQUATIC RESOURCES TO A TNW, THE TERRITORIAL SEAS, OR INTERSTATE WATER. N/A, the review area supports no aquatic resources.

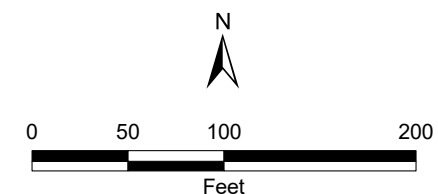
MFR Enclosure 1 – Aquatic Resources Delineation Map



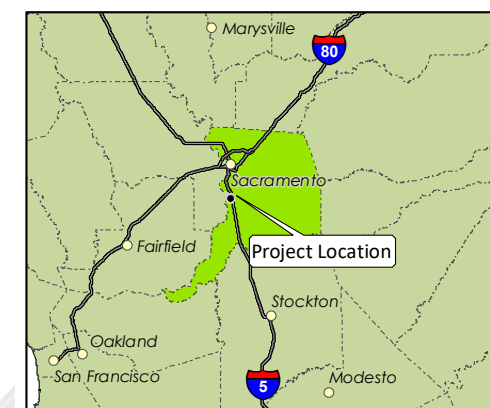
