MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322 (2023), ¹ [SPK-2024-00608]

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.² AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.³ For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA),4 the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 Rapanos-Carabell guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the Sackett decision (reference 2.d.) in evaluating jurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of "waters of the United States" found in the pre-2015 regulatory regime and consistent with the Supreme Court's decision in *Sackett*. This AJD did not rely on the 2023 "Revised Definition of 'Waters of the United States," as amended on 8 September 2023 (Amended 2023 Rule) because, as of the date of this decision, the Amended 2023 Rule is not applicable in this state due to litigation.

1. SUMMARY OF CONCLUSIONS.

a. The review area is comprised entirely of dry land (i.e., there are no waters such as streams, rivers, wetlands, lakes, ponds, tidal waters, ditches, and the like in the entire review area and there are no areas that have previously been determined to be jurisdictional under RHA in the review area). Based on the results of the associated aquatic resources delineation report and corroboration of supporting data, including aerial imagery, NHD and NWI layers, NRCS Web Soil Survey, and land use maps, the review area is comprised entirely of uplands.

- 3. REVIEW AREA. The approximately 118-acre project site is located between I-70 and SR-118, approximately 1 mile west of Sigurd, Latitude 38.8397°, Longitude 111.991°, Sevier County, Utah (AJD MFR Enclosure 1).
- 4. NEAREST TRADITIONAL NAVIGABLE WATER (TNW), INTERSTATE WATER, OR THE TERRITORIAL SEAS TO WHICH THE AQUATIC RESOURCE IS CONNECTED. The review area does not contain aquatic resources (AJD MFR Enclosure 2). The nearest TNW is the Sevier Bridge Reservoir (SBR), also known as Yuba Lake, located approximately 34 straight-line miles to the north of the review area. SBR is a "navigable water" for purposes of the CWA, is considered "traditional navigable waters", and therefore jurisdictional under 33 C.F.R. §328.3(a)(1) and 40 C.F.R. §230.3(s)(1). Waters are traditional navigable waters if they meet one of the following criteria:
 - Are subject to Section 9 or 10 of the Rivers and Harbors Appropriations Act of 1899;
 - Have been determined by a Federal court to be navigable-in-fact under Federal law;
 - c. Are waters currently being used for commercial navigation, including commercial waterborne recreation (boat rentals, guided fishing trips, water ski tournaments);

- d. Have historically been used for commercial navigation, including commercial waterborne recreation; or
- e. Are susceptible to being used in the future for commercial navigation, including commercial waterborne recreation.

The SBR meets Criteria c above, having been found navigable-in-fact under project number SPK-2008-01140. Thus, the SBR is a "traditional navigable water" and is regulated by the Corps under Section 404 of the CWA.

- 5. FLOWPATH FROM THE SUBJECT AQUATIC RESOURCES TO A TNW, INTERSTATE WATER, OR THE TERRITORIAL SEAS. The review area is comprised entirely of dry land (uplands). Based on available information, any surface flows potentially draining off site would flow generally to the east, through a series of ditches and culverts, and into the Sevier River, which flows north into the SBR (AJD MFR Enclosure 3).



the "Migratory Bird Rule." Include the size of the aquatic resource or feature, and how it was determined to be an "isolated water" in accordance with SWANCC. N/A.


