slightly lower topographic areas. Both features are heavily influence by irrigation, but do not have any ditch, pipe or other surface connections to other on-site or off-site waters that drain into a TNW.

Excess hydrology from features F, G and Q would flow north in a roadside ditch (no OHWM) and would not flow west over or under the roadway to Wetland E. In addition, Wetland E is separated from down-gradient Wetland D by at least 200 feet of uplands.

Wetland I extends up-gradient off site to the east, but wetland hydrology and soils terminate on site and do not extend down gradient to any other waters. Wetland I is separated from down-gradient wetlands west of the study area by approximately 450 feet of uplands. The Corps has determined that Wetlands E and I are isolated features with no interstate or foreign commerce connection.

The 1,073-foot Ditch P in the southern half of the study area is a non-tidal drainage ditch excavated in uplands that does not carry perennial flow. It is used for irrigation purposes and does not connect to other ditch or wetland features on site.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
