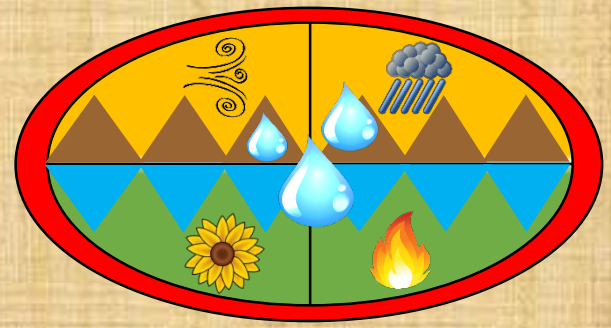

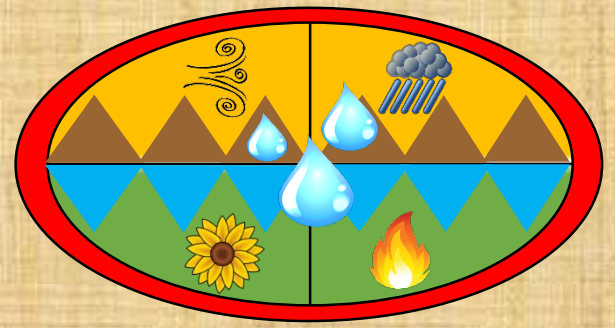

## District Success Spotlight

### Dr. Ron Kneebone

Our first District good news story comes from Albuquerque District (SPA):

USACE's first multi-Tribe sponsored Feasibility Study, the Espanola Valley Project, is moving toward finalization as a Chief's Report for presentation to Congress. The project's sponsors, the Pueblo of Santa Clara and Ohkay Owingeh, were instrumental in moving this environmental restoration project forward. The project involves a number of restoration measures along approximately 17 miles of the Rio Grande in the Espanola Valley.

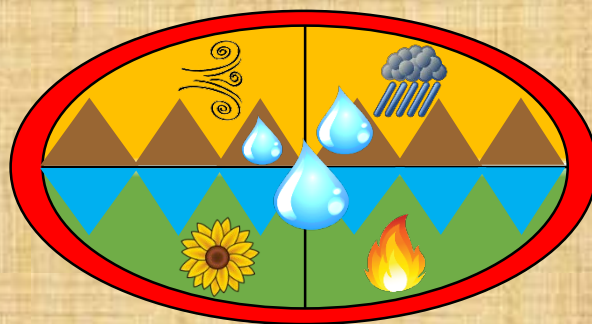
Almost simultaneously, the first Tribal Partnership Project initiated under the Section 203 Tribal Partnership Program, became the first tribal partnership watershed study in the nation to be completed this past 29 September. The project, sponsored by the Pueblo of Santa Clara, had as its goal the reintroduction of species along Santa Clara Canyon in the aftermath of a wildfire that occurred in 2000. While the project was gearing up in 2011, another wildfire decimated the canyon and its associated mountain forests. Demonstrating USACE's recognized operational flexibility, the project switched to an evaluation and assessment of the Post-fire Canyon and its wildlife.

The project teams led by Project Managers Patricia Phillips and Amanda Velasquez were supported by their multidisciplinary team at SPA, planners at Sacramento District, the leadership of SPD and HQ, and most importantly through the teamwork, support, and contributions of the people of the Pueblo Santa Clara and Ohkay Owingeh over these many years.

A ceremony will be held on November 30, 2018 in Espanola, NM to recognize this significant partnership achievement. Congratulations to the entire Team!

### TNTCX/IWR Partnership

USACE's Collaboration & Public Participation Center of Expertise (CPCX) and TNTCX have been coordinating with HQUSACE, and working with contractor Erika Wettergreen of MS-DAY, to explore ways to strengthen and enhance Civil Works water resources project development opportunities with Tribal Nations. Overarching goals of this effort include: (a) identifying how to help USACE and tribes enhance water resources planning capabilities and (b) suggesting collaborative processes and new (or improved) tools to promote efficient partnering between USACE, tribes, and other federal/state agencies under existing laws and authorities. Understanding how potential projects navigate through Section 203, FPMS, PAS, CAP, and IIS application/selection process will help us gain greater insights into the nuances associated with Tribal Nations pursuing these types of activities with the Corps. Our intent is to develop a report that identifies the range of Civil Works authorities/ project opportunities available to Tribal Nations, showcasing good examples of success. We will also provide a description of challenges that may impede or delay those project opportunities as well as suggest recommendations on how to remove barriers, clearly describe project approval pathways, and design outreach materials that support productive dialogue.

We anticipate conducting discussions with individuals and small groups to: (1) to better understand the past and present projects/activities pursued with Tribal Nations and (2) to learn about the procedures/ steps that are followed when evaluating projects/applications. Group discussions and individual interviews will be comprised of target staff from MSC leads, HQ Program Leads, and District personnel. The outcome of these interviews, the survey summary, and findings from our background research will be incorporated into the final report on Strengthening Collaboration Opportunities for Water Resources Projects with Tribal Nations.

Raising awareness of best management practices already in place and sharing success stories will be helpful to strengthening project development efforts with Tribal Nations. In addition, the implementation of suggested recommendations can support furthering those efforts and will build stronger, meaningful relationships and partnerships with Tribal Nations while also supporting Corps efforts that work to improve water resources planning and management.

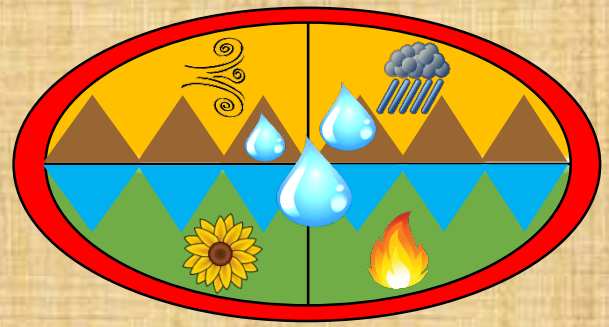
There are always challenges to carrying out a study like this, but the joint effort of IWR's CPCX and TNTCX in shaping the work, and providing oversight to the contractor, has been a great team effort and a positive example of two CX's collaborating on a project. CPCX Director Hal Cardwell states, "It has been wonderful to have the TNTCX acting in a technical capacity for this project, reviewing all the material and contributing to its refinement. It is great to have them be able to review, contribute to, and fully support the current technical approach developed with MS-Day."

### **Cultural Values Based Planning for Integrated Wetland Management on a Watershed or Reservation Scale – November 6th Webinar**

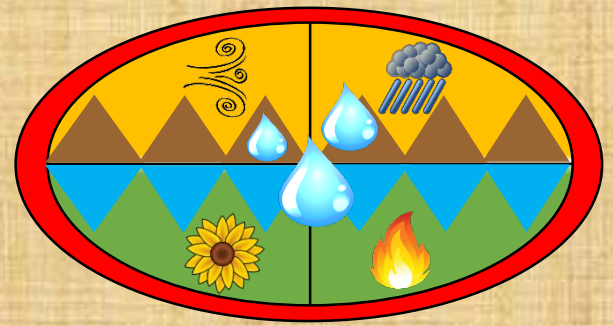
Dear friends and colleagues,

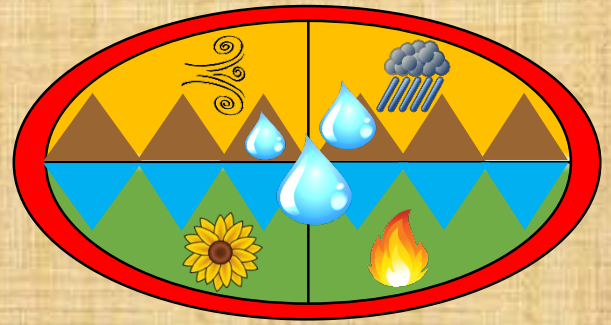
